Parish Council note the activity and expect government C19 regulations will be adhered to.

**BPC 2020-68 Receive reports from Nottinghamshire County Councillor and Newark and Sherwood**

**District Councillor. NCC Cllr S Saddington-** NCC are getting £25000 for surveying surface water flood risk in Bleasby, NCC will liaise with the Bleasby flood action group. The Bus shelter will be in by March 2021. Cllr Saddington is happy for the VE day funding money to be used for anything else for the village.

On April 21<sup>st</sup> the planned meeting with Network Rail was cancelled so a skype meeting was held. The people on the meeting were not the most appropriate people and so they took NCC concerns back to Network Rail. Cllr Saddington will chase this as there is still no answer.

A resident asked for an update re flooding and drainage on Main street, where does the area water discharge into? Cllr Blaney will contact Highways and internal drainage board.

**NSDC R Blaney-** Planning at Boat lane Caravan site, there is a requirement that caravans are removed between 31oct-1<sup>st</sup> April and the number of vans is limited to 30 caravans. Enforcement was taken when caravans were not removed and in excess of 30. The owner appealed against the enforcement notice for 18months. There has been recent notice of the appeal now starting, the owners have applied and accepted the enquiry to be via public inquiry and are stating that the caravans have been left on for the last 10 years. Anyone with proof either way please contact NSDC.

Councillor asked regarding planning and driveways; A driveway of more than 5 square metres needs planning permission.

With planning applications for trees, a case officer comes to visit the site, if they believe a more comprehensive scheme is required, they will contact the tree surveyor.

**Parish Council opposes the Caravan site appeal.**

Planning enforcement will be working with a property without planning on Main street.
