



Accessibility Statement for Bleasby Parish Council

Bleasby Parish Council is committed to ensuring that its website, www.bleasbycommunity.uk, is accessible and usable for as many people as possible. We aim to meet the accessibility requirements of the Web Content Accessibility Guidelines (WCAG) 2.2 Level AA.

We want as many people as possible to be able to use this website. For example, you should be able to:

- change colours, contrast levels and fonts
- zoom in without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader

How accessible this website is:

A recent accessibility review (December 2025) identified that most parts of the website are accessible, with a strong structure and clear content. However, we know that some parts of the website are not fully accessible:

Current known issues:

- Some historic PDF documents may not be fully accessible
- Some third-party embedded elements may not meet WCAG 2.2 AA
- Some older documents lack proper tagging for screen readers

Disproportionate burden assessment

Bleasby Parish Council is a small public body with limited financial and staffing resources. We have assessed the cost, time, and technical capability required to make every part of the website fully accessible.

We believe that fixing the following issues would impose a disproportionate burden at this time:

Historical documents

Many older documents (particularly PDF and Word files), including meeting minutes and agendas, were not created in an accessible format. Converting the full set of documents into tagged, accessible documents would require significant staff time and specialist support, which would:

- Divert limited staff resources
- Affect the delivery of essential Council services
- Incur costs that are not proportionate to the benefit

Therefore, we do not currently plan to make all historical documents accessible.

Third-party systems

Where we embed third-party plug-ins, maps, or widgets, we have no direct control over their code. If these tools fail to meet accessibility standards, this is outside our technical control and may represent a disproportionate burden to fix.

We regularly review this assessment to ensure it remains accurate.

What we're doing to improve accessibility

We are working to resolve the identified problems and ensure new content meets WCAG 2.2 AA. Our current improvement plan includes:

- Reviewing all page alerts
- Improving accessibility of future documents
- Conducting periodic accessibility checks
- Ensuring all new PDFs meet accessibility standards
- Reviewing website templates for keyboard and screen-reader compatibility

Preparation of this accessibility statement

This statement was prepared on 8 December 2025 and reviewed and approved by Bleasby Parish Council on 12th January 2026.

It will be reviewed annually or sooner if significant updates are made to the website.
