BPC 2020-81 Receive Questions from the Public a resident stated that he was unhappy that the analysis he prepared and his comments thereof were not Minuted at last month's meeting. He prepared analysis for Ulyetts for last year and found an overpayment for £522 meaning Council should therefore only pay £16 last month. An extra payment has still gone out again to Ulyetts, resident suggests that this is a disciplinary issue. Clerk explained the administration issue that has happened. Resident also stated that the Noticeboard was not up to date and the Month is incorrect on this month's Agenda. Grass from Highcross and Gibsmere will be cut next Friday. Resident said that the budget needs finalising for the hedges, Chairman stated that the budget is the same as last year. Chairman suggests that hedge cutting glebe field and Meadow hedge maybe put forward, resident will put forward a schedule once he has the budget and we need to get this done quickly Clerk to confirm Lengthsman monies with NCC

Resident offered to work in a working party to enable residents to make better use of the ponds, Council agreed that this is a good idea

A resident stated that he copied an email to chairman with his views on finances. There are still some issues to be picked resolved by September

District Councillor Blaney reported to the meeting that, parish councils holding virtual meetings has gone better for smaller councils. Virtual meeting must be continued at present. Old Norse house have put in to appeal the application refusal and will be appealed by letter and specifics of NSDC comments used. Clerk to email District Council comments to Councillors and reiterate parishes position to NSDC by end of July The enforcement notice at Boat Lane wording was incorrect, therefore the notice has to be withdrawn as too the appeal. The situation is ongoing

Holme Dyke, the definitive position from Trent Valley Drainage Board is that the pipe that goes under Horsestead is the responsibility of Horsestead as riparian owners. Trent Valley Drainage Board are responsible when the pipe comes out from Horsestead. Trent Valley Drainage board give permission for the culvert at Old Norse House and Trent Valley Drainage Board are responsible for it. NCC drainage kerbs, they do not need permission from NCC for water running from Station Road into Holme Dyke. Resident pointed out that it is still not known where the water is going

Clerk to find out NCC flooding survey from Flood Action Group as parish Council has areas of concern
