## Minutes of the Parish Council Meeting Monday 13 November 2017 7.30pm Bleasby Village Hall

Welcome by Chair

Cllr Cast welcomed those present and explained that the clerk had been delayed. Cllr Gent would be taking notes until her arrival.

BPC 17-391 To receive and resolve to approve apologies for absence.

Cllr Coombs had given his apologies and the council approved them.

BPC 17-392 To receive questions and petitions from the public – for information only.

A member of the public thanked those who attended the Jubilee Ponds

Management Group and Parish Council meeting.

A member of the public reported that someone had been burning rubber and requested something was put in the Bleasby News. Cllr Cast replied that something would be added to Bleasby News. Environmental Health matters such as burning of rubber should be reported straight away to Newark and Sherwood District Council 01636-650000.

BPC 17-393 To receive a report from the County and District Councillors.

Cllr Blaney reported that it might be necessary to re-register and possibly have some training to rejuvenate the Neighbourhood Watch group due to data protection rules changing.

A meeting with Robert Jenrick MP and Ian Prosser, Director of Safety & HM Chief Inspector of Railways, to discuss issues following installation of automatic barriers had highlighted three main problems:

- No onus on Network Rail to report problems to HM Inspector
- No query from HM Inspector as to how the work went
- Lack of urgency or attention to deal with problems once highlighted

There will be a meeting of Cllr Blaney and Mr Posser on Thursday 24<sup>th</sup> November. He had also chased a reply regarding an issue highlighted by a member of the public and that he had reported.

The work at Fiskerton was now complete – huge improvement but should have been done at installation.

Cllr Saddington reported that the double white lines had been extended though not as far as previously.

She would be writing to Chris Ward at Nottinghamshire County Council to stress how important the bus service is to the village. She pointed out that people might have to stay longer at their destination as the bus route would be extended to Newark and turnaround would take longer than before. The bus would also be fare paying.

She encouraged the Council to apply for 5 free salt bags that could be used anywhere in the village. She would also be able to support the purchase of a £155 blue salt bin to be placed anywhere in the village.

BPC 17-394 To receive disclosures of pecuniary and non-pecuniary interests.

Cllr Gent reported that the Traffic Management Working Party would not meet until January.

Cllr Cast asked if there had been a consultation of properties on Gypsy Lane yet. This had not yet been done as more information from VIA was required.

- 2. Verbal report on Lengthsman's work undertaken in October and his scheme of works for November and December.

Verges around the village had been cut and benches painted with preservative. The council asked for the verges on the approach to the village to be managed.

- 3. Council contractor's scheme of works for November and December. The Glebe Field hedge had been cut and the contractor would give the field another mow if necessary before the end of the month in preparation for the Christmas event on the 9<sup>th</sup> December.
- 4. To report on the joint meeting with JPMG.

It was reported that the meeting had been very positive.

It had been agreed that communication between JPMG and the Parish Council would be improved further.

The JPMG understood they were not a committee of the Parish Council. An information sheet or flyer would be developed and distributed with Bleasby News.

An open day event would be planned at the ponds.

The fishermen invited the council to arrange an "introduction to fishing" event. It was considered that increasing the general footfall was likely to alleviate the dog fouling problem so more people should be encouraged to use the ponds. More seats around the ponds would be required.

Feedback on both questionnaires about the ponds would be collated.

The need for gravel purchases could not easily be predicted.

5. Progress report Gypsy Lane verges/barriers

The Clerk explained that she was waiting for a quote from VIA.

6. Update on Ferry End discussions with Larken and Co, Solicitors Cllr Cast reported that the solicitors had submitted the paperwork to him but that the sketch excluded the river bank. He had taken advice from the solicitor that the area could be extended to include the riverbank.

# Proposed by Cllr Cast seconded by Cllr Gent the council unanimously resolved to extend the area to include the river bank.

7. Update on arrangements for official agreement and erection of Flood/Equipment Store

The shed had been ordered and was being shipped. It was expected before the end of the month.
