- BPC 18-654 To receive questions and petitions from the public for information only. A member of the public thanked the Council for the efforts recently undertaken around the parish. The Glebe Field had been cut to a high standard.
- BPC 18-655 To receive a report from the County and District Councillors. Cllr Saddington informed the Council about the County Council's plans to review the current structure and to offer alternatives to a unitary authority for Nottinghamshire. She explained that this was likely to be considered at the next Nottinghamshire County Council meeting 10 December 2018. She reminded those present of the lighting of the Christmas Tree at County Hall on 30th November, when Bleasby School would be providing the choral input. She gave her apologies for the next meeting on 10th December due to other

Land and Assets:

To receive an update on the Jubilee Ponds.

Cllr Cast reported that the Council had been working closely with Bleasby Carp Syndicate and Mr P Wood who had been doing an excellent job. The Centenary Wood had been prepared for the Remembrance weekend. Cllr Dunning asked if the Council should encourage people to look after their own tree and the immediate area around it and keep it weed free. Cllr Cast stated there were approximately 6-8 plots still available for trees to be planted.

Lengthsman's scheme of works for November

The Council asked for the lengthsman to clear the grips of debris and give the verges a last cut before the winter. The clerk would ask for photographic evidence of work completed to be submitted with the invoice.

Proposed by Cllr Andersen, seconded by Cllr Dunning, the Council resolved to prepare a tender document for the provision of lengthsman and contractor work in the village. Cllr Andersen agreed to liaise with members of the public to draw up the tender document with a view to obtaining quotes following approval at January's meeting.

Proposed by Cllr Coombs, seconded by Cllr Foster, the Council resolved to object as the proposed elevations would take up the complete width of the plot and would thus not be in keeping with the local area. The roof area would be substantially increased resulting in greater run-off and a flooding risk for this and neighbouring properties.
