A member of the public pointed out that that many of the stalwart volunteers in the village were in their seventies or older. He suggested that in future it may not be possible to rely on volunteers to get jobs done and that the precept should be raised to pay somebody to do the work.

A member of the public asked why the budget had been cut. Cllr Andersen explained that the budget had not been cut, rather that in previous years the council had spent in excess of the budget set, thus the need to draw on reserves. He explained that the council were trying to stay within the set budget for its expenditure this year.
